## **NUKI PRO SHOP TERMS AND CONDITIONS**

In the Nuki Pro shop you benefit from a fully automated ordering process. As soon as your order is completed, it is transferred to our system and processed. No products can be added or removed once an order has been placed. Delivery times are as indicated in the Pro shop.

For orders with a value of less than € 759.00, a flat rate of € 8.40 will be charged for shipping and handling. If this order value is reached, delivery is free of shipping costs, provided it is a separate order. Individual orders cannot be combined so that the order value is reached.

If you choose "Payment in advance" as your payment method, the order will only be processed after the transfer has been completed. You may send a transfer confirmation to [pro@nuki.io](mailto:pro@nuki.io) so that the process can be initiated in advance.

Nuki reserves the right to adjust the prices or the composition of the product bundles at any time.



## **RETURN POLICY**

Please note that only proven defective devices may be returned. Functioning devices cannot be returned.

All Nuki products must be registered before returning. All returned goods that arrive unannounced (without RMA number) at our logistics partner will not be assigned and processed further. Please contact [pro@nuki.io](mailto:pro@nuki.io) before returning goods.

Any shipping costs that may incur will be covered by the sender and will be settled by Nuki with a € 15 credit note for the Nuki Pro shop.

## **CONTRACT DURATION/EXCLUSIVITY**

The partnership can be terminated monthly, at the end of each month, by either side without giving reasons.

Nuki does not grant regional exclusivity rights to its Pro partners.
